As per the existing instruction of the Panchayati Raj Department, DRDAs of all the 30 districts of the State remit funds under various schemes to DRDA Khurda, SIRD,ORMAS, etc. for the purpose of meeting State level expenses in connection with implementation of various schemes. It is learnt that while some DRDAs obey Govt. instructions strictly, some other do not. It is also learnt that a number of instructions from P.R. Deptt. have been issued to all DRDAs at different points of time creating confusion at the DRDA level. Therefore, in order to avoid any confusion, it is hereby clarified that the DRDAs are to remit funds under various schemes for expenses at State level as per the following details.
