MoPR-UNDP Capacity Development for Local Governance Project

1. Capacity Development for Local Governance (CDLG) is a joint venture of the Government of India and UNDP which is implemented by the Ministry of Panchayati Raj (MoPR) in seven UNDAF states including Orissa. Panchayati Raj department is the Responsible Party for this project in this state. Panchayati Raj Department intends to apply part of the proceeds of this grant to payments under the contract for Consultancy services for developing Capacity Building Strategy Document & State Perspective Plan for Orissa
2. The services include preparation of :
 - **Capacity development strategy document** strategizing on making PRIs more effective in the State. This would include training, capacity building, advocacy and strengthening of capacity development institutions and networks of PRIs.
 - **Training perspective Plan** focusing on time bound delivery of capacity building and training to 100% elected representatives and PRI functionaries in the state. This would also include developing a training calendar for SIRD.
3. The duration of the consultancy for the concerning subject should not exceed **20 days**.
4. SIRD, Bhubaneswar now invites eligible consultants (individuals) to indicate their interest in providing the Services for preparation of above mentioned documents. The Consultant should possess the following requisite qualification and experience:
 - a. Minimum Masters degree in management or any other discipline
